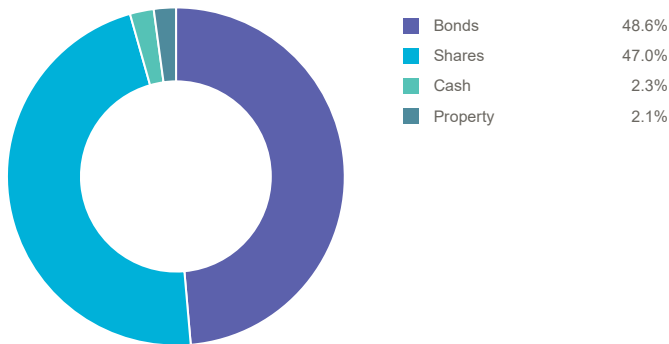

## FUND DESCRIPTION

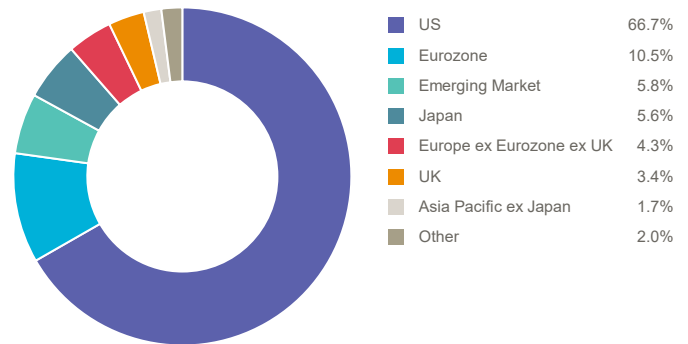

## ASSET ALLOCATION



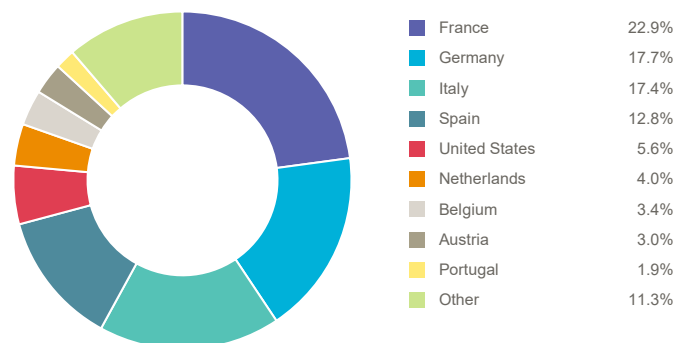
