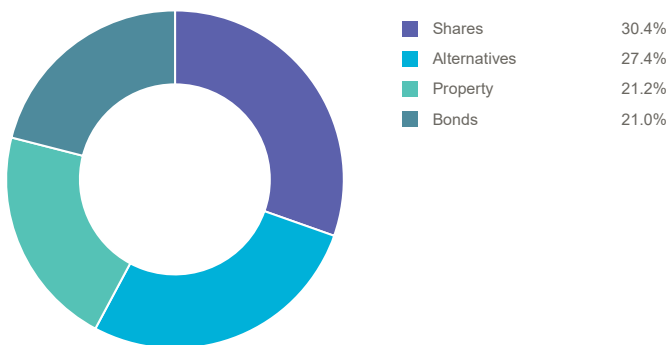

FUND DESCRIPTION

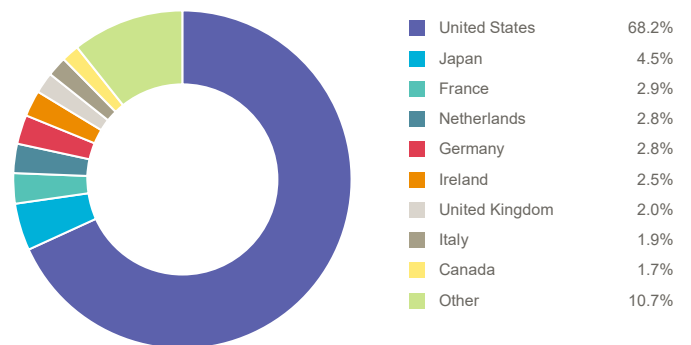

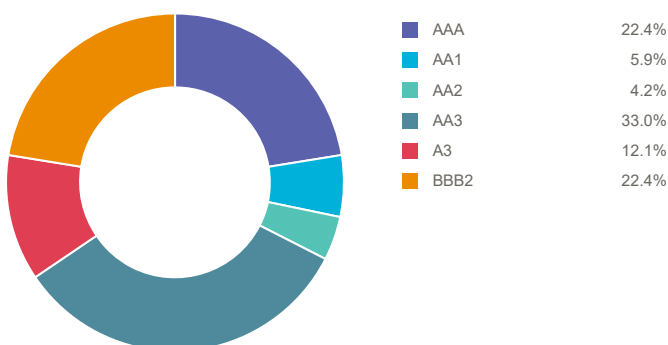
ASSET ALLOCATION

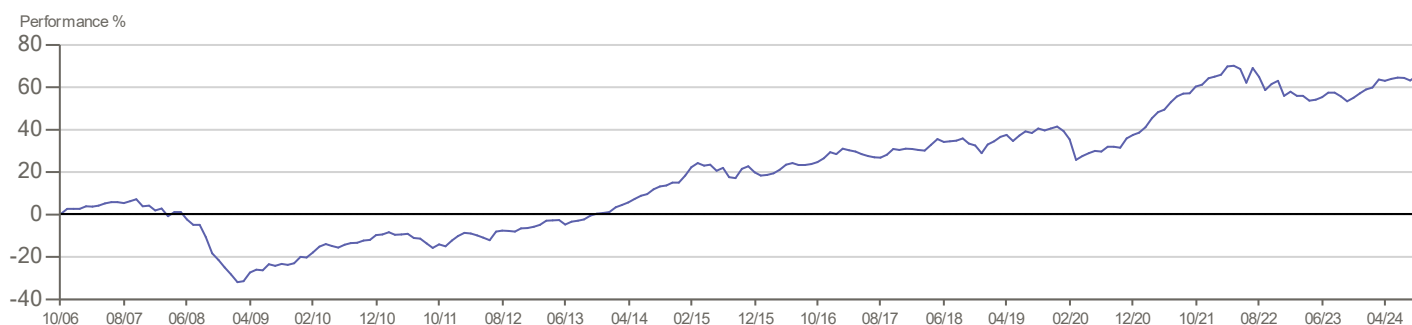
