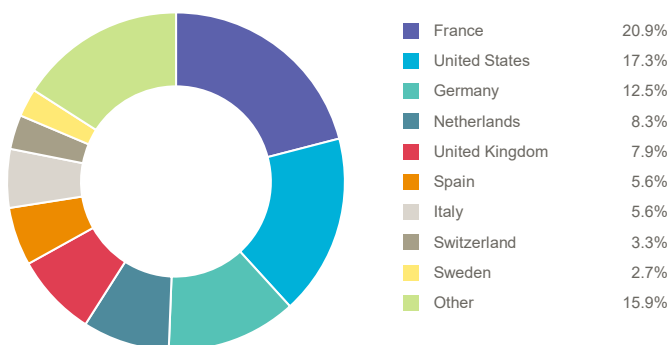

FUND DESCRIPTION

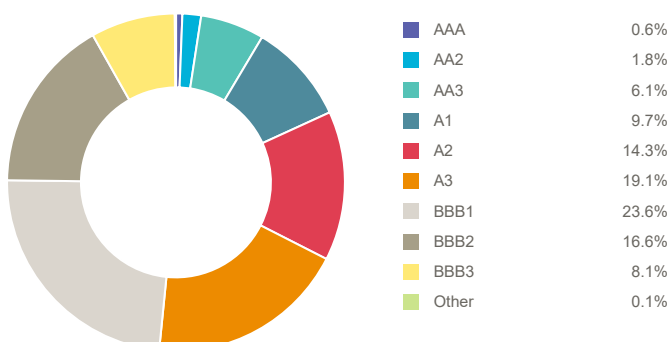

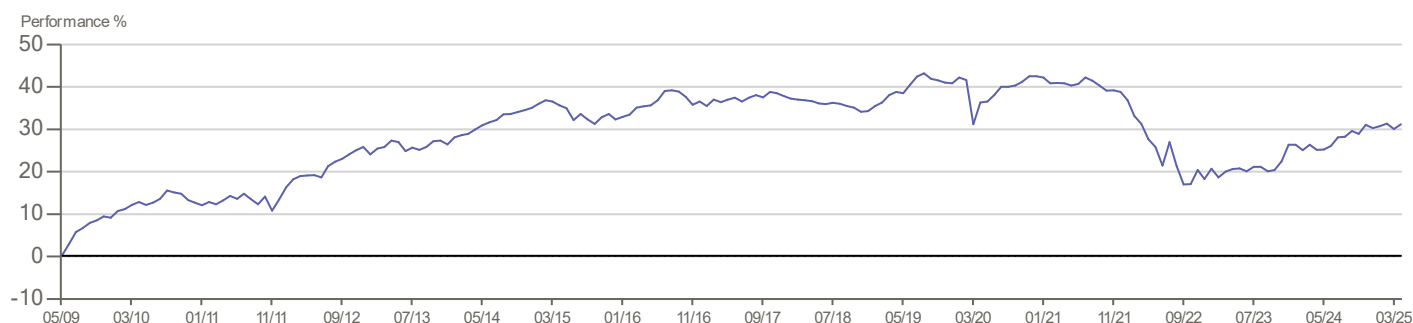
