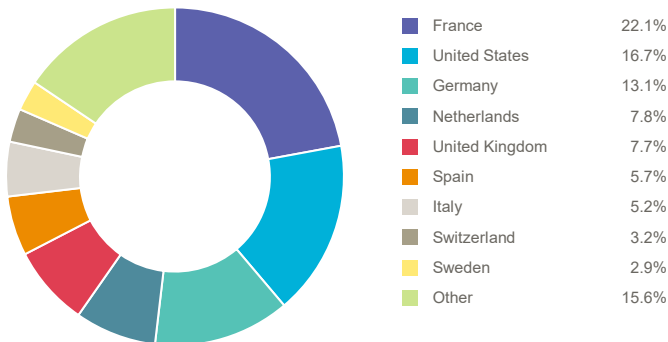

FUND DESCRIPTION

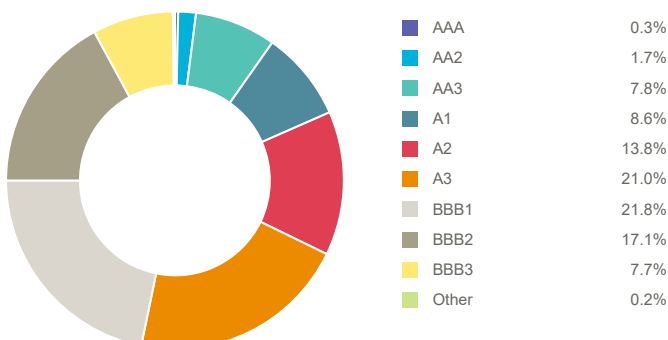

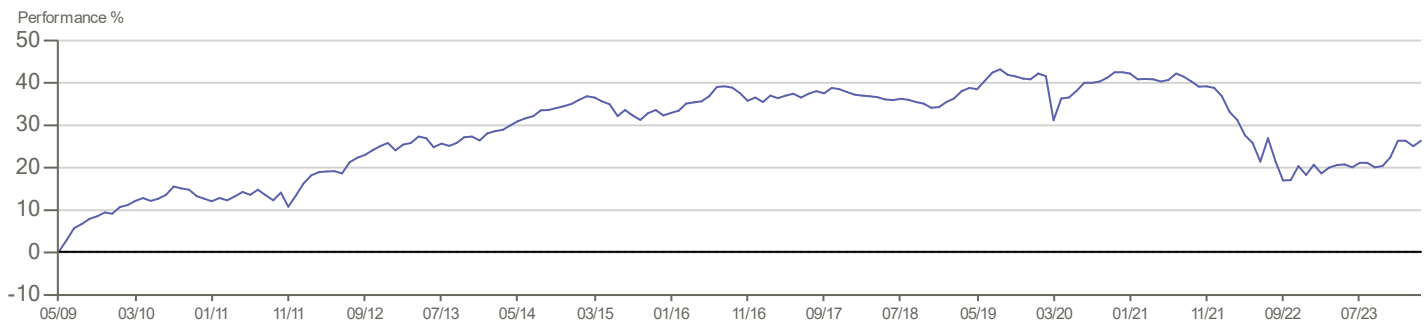
