FUND DESCRIPTION

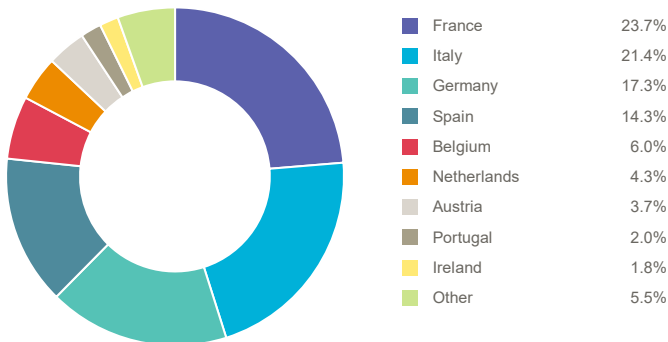

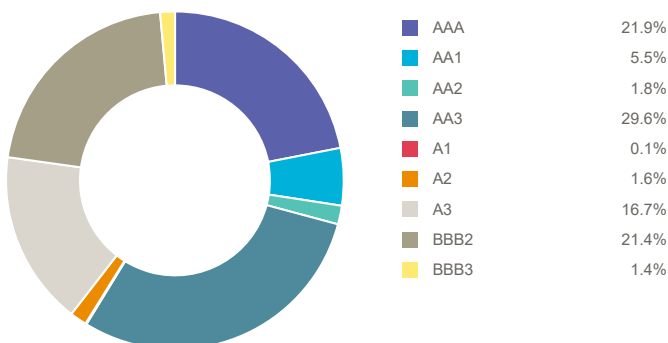

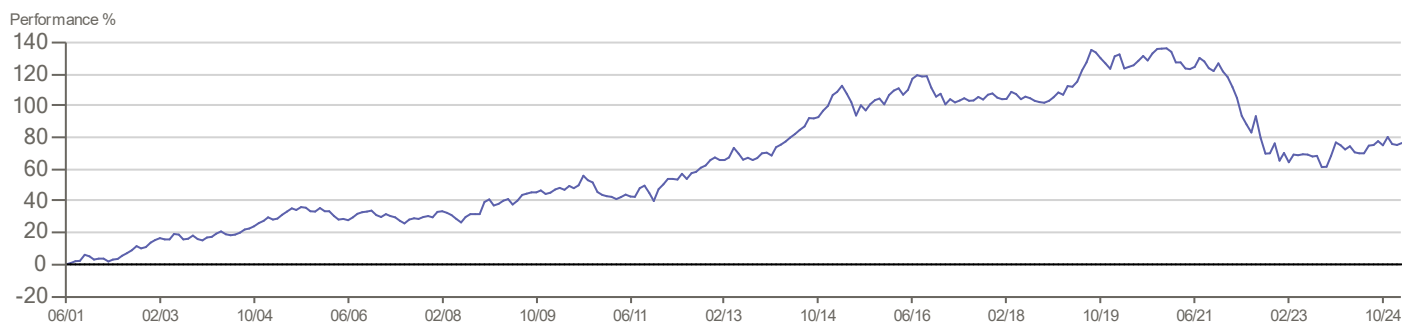
