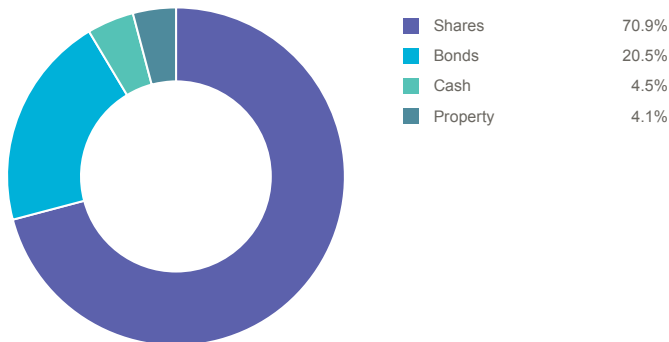

FUND DESCRIPTION

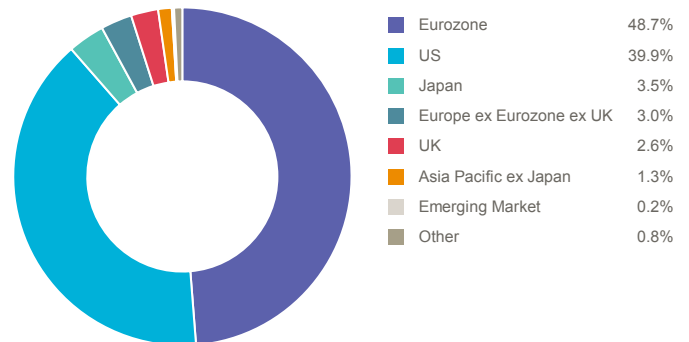

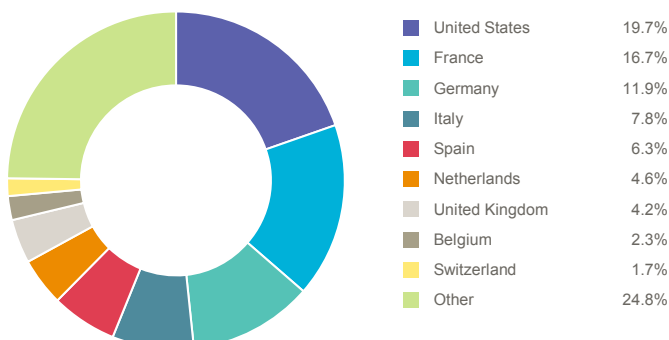
ASSET ALLOCATION



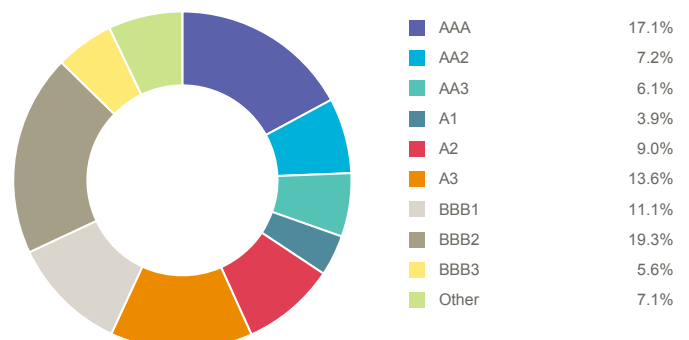
SHARE REGIONAL DISTRIBUTION

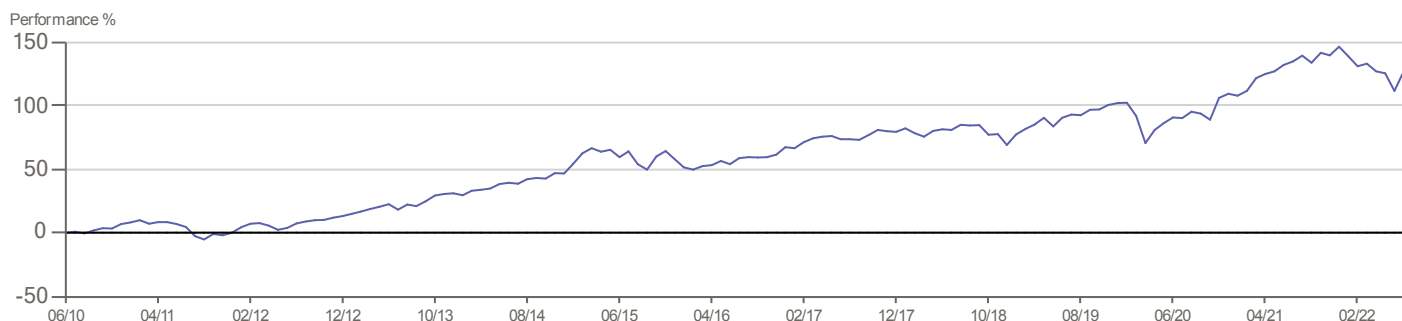
