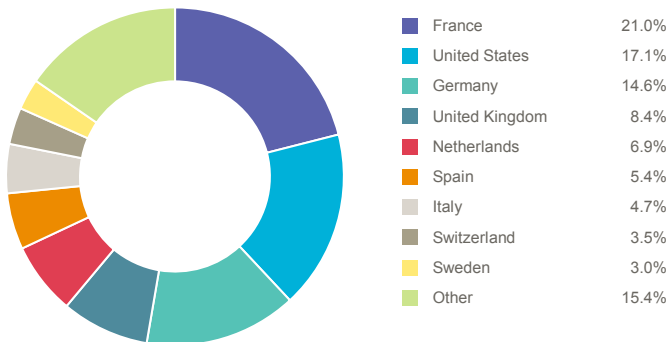

FUND DESCRIPTION

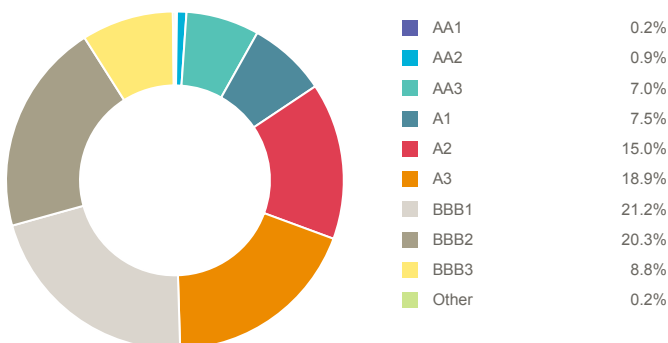

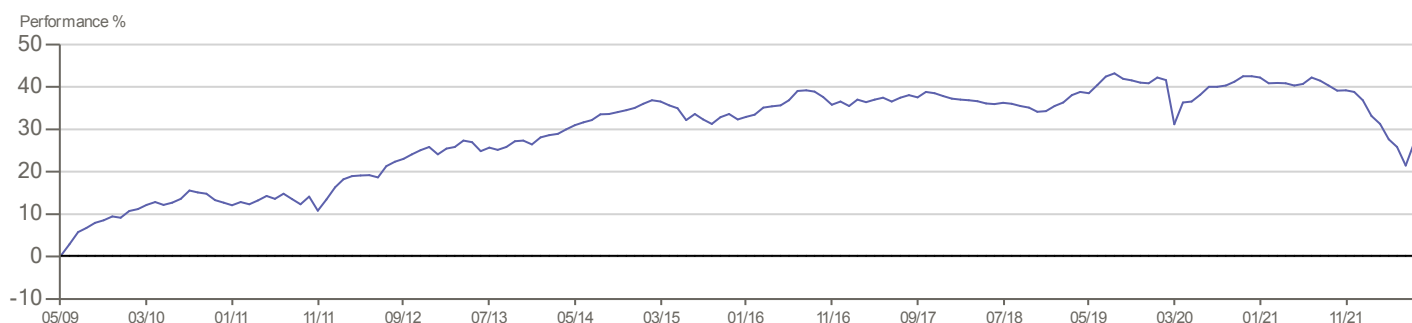
