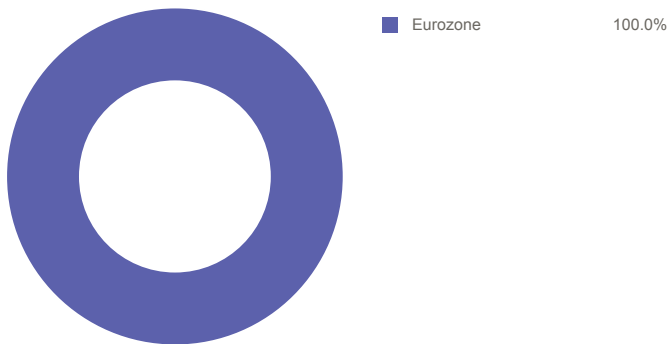

FUND DESCRIPTION

The idea behind indexed funds is simply to consistently perform in line with the agreed benchmark index, in this case the Euro Stoxx 50 Index. We achieve this by either investing in the same assets as that of the index or holding assets that will perform in line with the index. This strategy allows investors to remove the risk of poor share choice.
