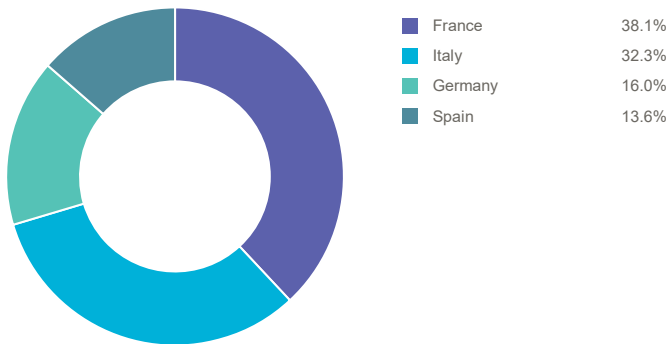

## FUND DESCRIPTION

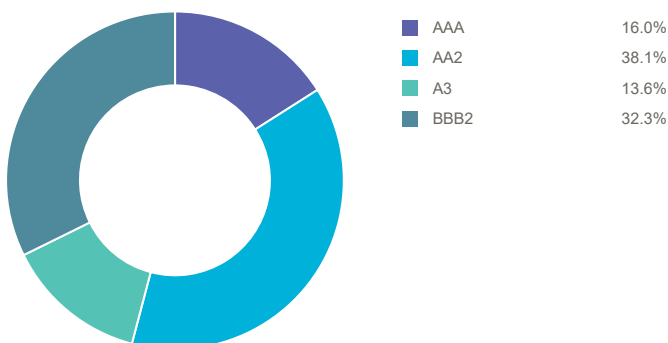

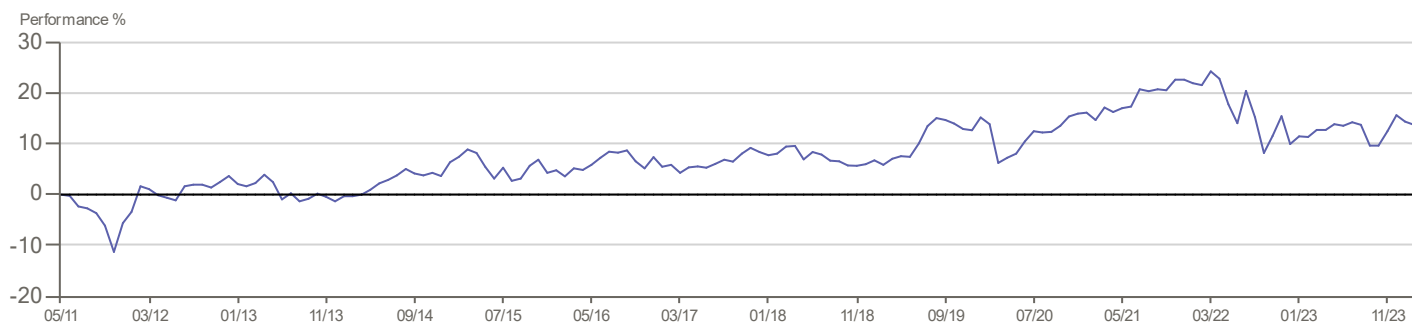
