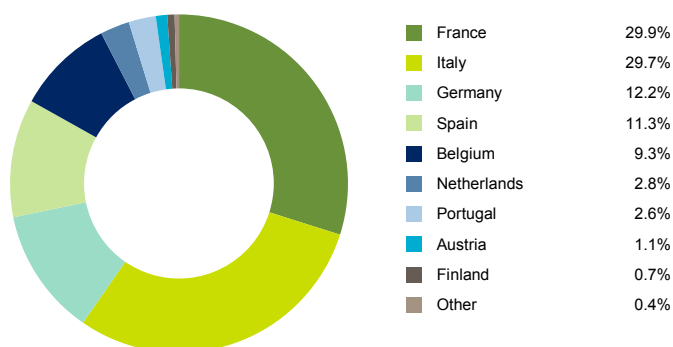

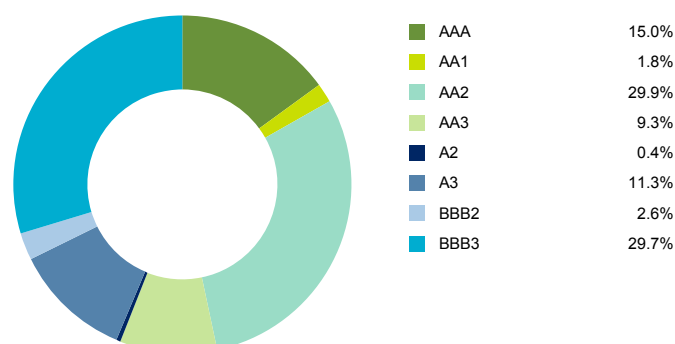
BOND COUNTRY DISTRIBUTION

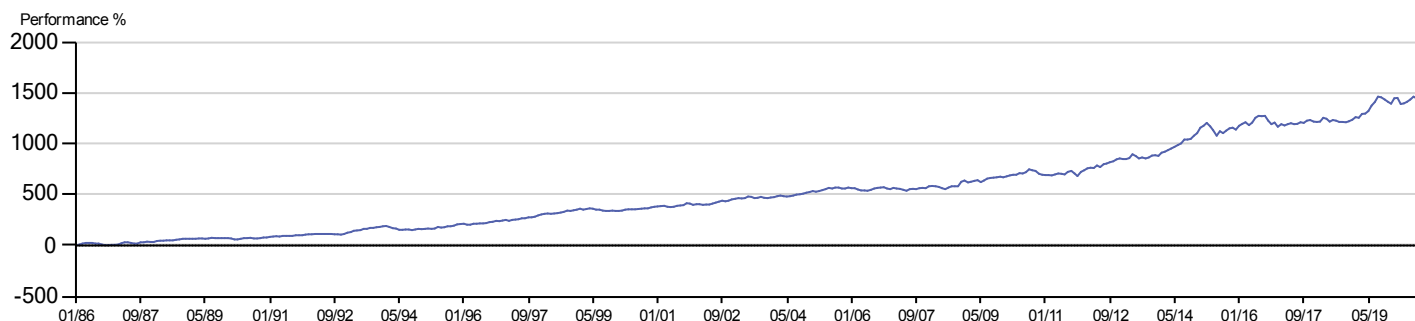
